
**ORDER**

This matter came before the Court on the motion of Defendants to Terminate the Provisions of the Stipulation entered on January 5, 2007 [Doc. 268] in Case No 2:04-CV-0692 and on the motion of Plaintiffs' for Status Conference [Doc. 242] in Case No. 2:04-CV-1206. Counsels for the parties in both of the above cases have conferred with the court on the record at a joint status conference on January 13, 2011. The parties agree and the Court Orders as follows:

1. The legal assistance program established pursuant to the Stipulation in Case No 2:04-CV-0692 has appropriately provided youth with access to counsel consistent with obligations under the Federal Constitution;

2. Defendants intend to continue the legal assistance program as it is presently constructed, although staffing levels and payment schedules may be altered in response to changed circumstances;
3. The parties agree that a guiding principle set out in Stipulation Para 25 in Case No. 2:04-CV-1206 describes the continuing duty of Defendants to provide access to counsel;
4. The monitoring of the legal assistance program in Case No. 2:04-CV-0692 has been thorough and helpful and no further intensive monitoring is needed to ensure that Defendants continue to provide youth with access to counsel;
5. Monitoring under SH shall include compliance with Stipulation paragraph 25. ;
6. The Defendants having successfully satisfied the terms of the Stipulation in Case No. 2:04-CV-0692, the court supervision of the Stipulation in that case shall be terminated;
7. Vincent Nathan is hereby relieved of his duties as monitor in Case No. 2:04-CV-0692 and thanked for his service;
8. The Parties agree that access to records related to legal assistance shall be continued.
